Registration of REPPA with SEDA Malaysia

Softcopy of REPPA signed with Distribution Licensee to be uploaded into system within 4-6 weeks

Scanned soft copy of the duly executed and stamped REPPA Agreement

Hard copy of the above certified as a true copy by an Advocate & Solicitor of the High Court of Malaya or a Commissioner of Oaths





Public License (Provisional) from Suruhanjaya Tenaga

To be applied within 30 days after issuance of FIAH Certificate

Scanned soft copy of the Public License (Provisional) from Suruhanjaya Tenaga

Hard copy of the above certified as a true copy by an Advocate & Solicitor of the High Court of Malaya or a Commissioner of Oaths.





Financing Agreement(s)

To be completed before appointment of EPC contractor

Scanned soft copy of the bank account latest 3 months statements showing a minimum credit balance of 5% of the capital cost. (applicable to company only).

Scanned soft copy of the financing agreement(s) and related documents entered into in respect of the financing or refinancing of the renewable energy installation





1st Payment to EPC Contractor

Scanned soft copy of a letter from the FIA Holder's financier confirming that funds have been released to the FIA Holder for the 1st drawdown under the Financing Agreement(s).

Scanned soft copy of the official receipt from the Contractor





Initial Operation Date (IOD)

Documents to be uploaded into system within 5 days after IOD occurred

- Scanned soft copy of the report / confirmation by DL that the revenue meter has been installed
- Scanned soft copy of the acceptance test certificate issued by a qualified person
- Scanned soft copy of the ST Public License (Permanent).
 Hard copy of the ST Public License (Permanent) certified as a true copy by an Advocate & Solicitor of the High Court of Malaya or a Commissioner of Oaths
 - Required to apply 3 Months from ST before Initial Operation Date_(IOD)
- Scanned soft copy of the written confirmation from the FiA Holder that the initial operation date has occurred, accompanied by:
 - a) A certificate from a qualified person stating that the renewable energy installation and interconnection facilities have been designed and constructed in accordance with prudent utility practices; and
 - b) The distribution licensee's written acceptance of the initial operation date proposed by the FiA Holder





FiT Commencement Date

Documents to be uploaded into system within 14 days after FitCD occurred

- Scanned soft copy of the written confirmation from the FiA Holder that the FiT Commencement Date has occurred, accompanied by a certificate from a qualified person; stating that the renewable energy installation has successfully completed a reliability run in accordance with the requirements of the Renewable Energy (Technical and Operational Requirements) Rules 2011
 - Reliability Run of all renewable energy installations connected to a connection point through a medium or high voltage direct connection are seven (7) continuous days as per "Guideline and Determination of the Sustainable Energy Development Authority Malaysia" requirement
- Scanned soft copy of the testing and commissioning report confirming the applicable bonus FiT criteria.(installation in buildings or building structures)
- Scanned soft copy of the written confirmation by a qualified person that such modules and/or inverters (as the case may be) were installed in the renewable energy installation. (solar photovoltaic modules)

Enhancements



Registration of RE Developers/Applicants

- Minimal Age for Registration of RE Developer/Applicant
- Supporting documentation of each share-holders of RE Developer
- Request for Change due to typo mistake in Applicant/Company Particulars (excluding MyKAd No/Registration No)
- Limit of 30MW Solar PV accumulative installed capacity per RE Developer/ Applicant



Enhancements Icont'dl



Application of Feed-in Tariff

- Unique Parcel Identifier (UPI) of Project site
- Latitude & Longitude (GPS) information of Project site
- Proof of Project Site Ownership Information
- Workplan for all proposed Project Milestones
- References of supporting documents to be uploaded
- Enhanced Email Notification to FiA holders
- Control of Distribution Licensee by State/Locality
- Online Declaration and softcopy to be uploaded within 3 days
- Feed-in Approval Limit per RE Developer/Applicant per day

Capacity of RE Developer/Applicant to raise equity up to 5% of Project Cost

Request for Change due to typo mistake in Feed-in Approval details (excluding DAA, Installed Capacities & Workplan)

Request for Correction in Applicant's MyKad No/Company Registration No

Introduction of Net Export Capacity of Energy

Improved DAA computation mode based on Net Export Energy



Enhancements Icont'dl



Processing of FiA Application

- Online Enquiry on Feed-in Approval application and Project Status
- Sending Notifications and reminders
- Reclassification of solar PV category
 - Individual up to 12kW
 - Non-Individual up to 500kW
 - Non-Individual more than 500 kW
- Net Export Capacity & Type of REPPA on FiAH certificate
- No Multiple Feed-in Approval applications on one project site



Enhancements Icont'dl



Management of Feed-in Approval

- Withdrawal of Feed-in Approval submission
- Cancellation of Feed-in Approval
- Refusal and Revocation of Feed-in Approval
- Transfer of Feed-in Approval
 - Individual to Individual
 - Company to Company
